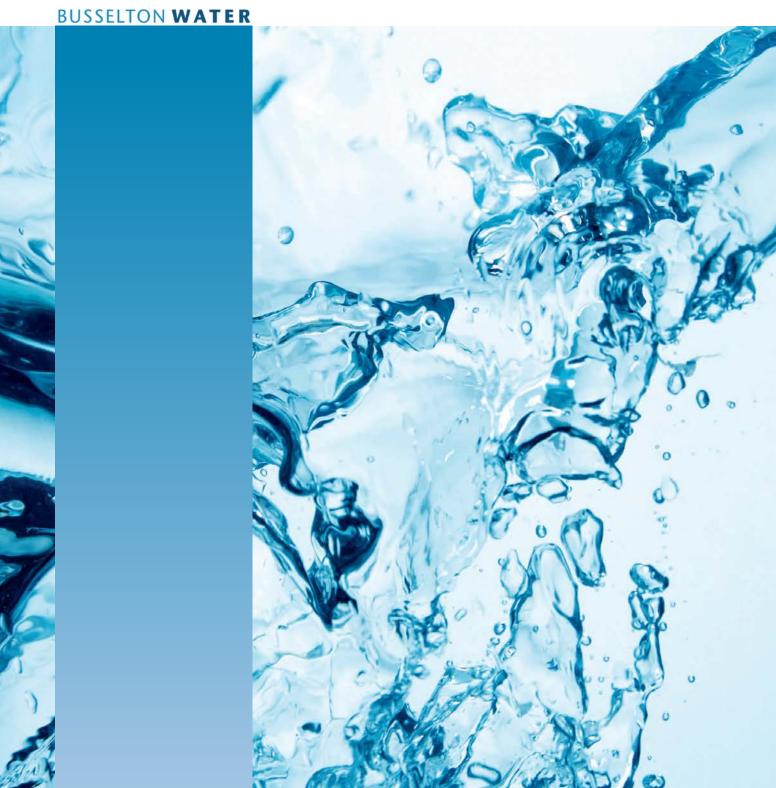

Comments

Operating Profit After Income Tax is favourable to budget due to higher than planned revenue from new connections and developer contributions. Water consumption revenue is also higher than anticipated due to growth and a drier climate.

Year-to-date expenditure is tracking 3% under budget due to savings in the salaries and on costs and other expenditure items are favourable to budget due to the timing of actual expenditure in comparison to budget phasing.

Year-to-date Net Accruals to Government are above budget and in line with full year forecast. Lower than planned payroll tax reflects savings in salaries and local government rate equivalents have not yet been paid. The income tax equivalent (NTER) is above budget after the third quarterly payment in March 2015. Busselton Water's tax liability is paid quarterly in direct proportion to gross income.
