6. Winner Selection and Notification

- The competition closes at 4:30pm Thursday 12 October 2023.
- Busselton Water will shortlist five entries (storyboard) per age group, Years 1-3, 4-6, 7-9 and 10-12
- Shortlisted storyboards will be shared on Busselton Water's Facebook page, and a voting process will take place.
- The winning entries will be the top entry (storyboards) in each age group, Years 1-3, 4-6, 7-9 and 10-12, that receive the most votes across all channels by 3:30pm on Thursday 19 October 2023.
- Winners will be announced Friday 20 October 2023.

Collection of the prize will be arranged with the prize winner directly. The winner's may be asked to participate in a photo and have their first name used in a competition winner announcement. The winner's name and photograph may be published on the Busselton Water channels including, but not limited to, website, social media and corporate publications. The winner's may also be given an option to participate in other publicity.
